- (f) Present the weights, measures, weighing or measuring instruments as the case may be, manufactured and meant for use within the State, to the Inspector for verification and stamping before sale.
- (g) Present the weights, measures, weighing or measuring instruments as the case may be manufactured and meant for use and outside the State and comvered under the First Schedule of the Inter State Verification and Stamping Rules, 1987, to the Inspector for verification and stamping before sale and.
- (h) Submit the application for renewal of this licence, as required under the Rules before atleast thirty days of the date of expiry of the validity of the licence.
- (2) Every condition prescribed after the issue of this licence shall, if notified in the official Gazette, be binding on the persons to whom the licence has been granted.
